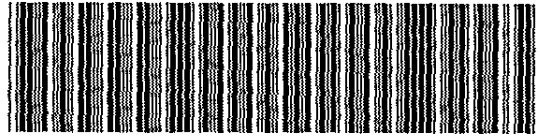

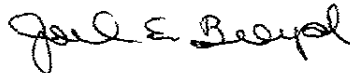

I. The dated of filing of the Articles of Organization of P & M ASSOCIATES, L.L.C. was March 3, 2005.

II. The Members of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby adopt the following Amended and Restated Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be P & M ASSOCIATES, L.L.C. (the "Company").

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The mailing address and street address of the principal office of the Company is: 13 Windjammer Point, Merritt Island, Florida 32952.

ARTICLE III - DURATION

The term of existence of the Company commenced with the filing of the Articles of Organization with the Secretary of State of the State of Florida on March 3, 2005, and shall continue perpetually, unless sooner dissolved pursuant to the Articles of Organization or Regulations of the Company, or by operation of law.

New Members shall be admitted only with the unanimous consent of, and upon terms unanimously approved by, all of the Members.

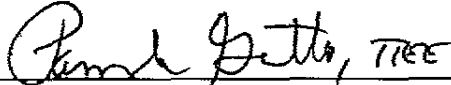
ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS
