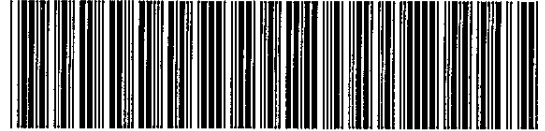

The mailing address and street address of the principal office of the Company is: 1332 Funston Street, Hollywood, FL 33019.


**ARTICLE III.
