


## ARTICLES OF ORGANIZATION OF SOUTHERN HOMES DESIGN & CONSTRUCTION, LL

Pursuant to the Florida Limited Liability Company Act (Chap. 608, Florida Statutes), as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

#### ARTICLE I NAME

The name of this limited liability company (the "Company") shall be **SOUTHERN HOMES DESIGN & CONSTRUCTION**, LLC.

#### ARTICLE II DURATION

Unless earlier terminated pursuant to the Act or any written operating agreement among the Members of this Company, the period of its duration shall be perpetual.

## ARTICLE III ADDRESS

The mailing address and the street address of the principal office of this Company shall be 2515 Dundee Drive, Tallahassee, Florida 32308.

#### ARTICLE IV REGISTERED AGENT

The initial registered office of this Company shall be 2515 Dundee Drive, Tallahassee, Florida 32308, and its initial registered agent at such office shall be Walter V. Culley, II.

#### ARTICLE V ADDITIONAL MEMBERS

Pursuant to Section 608.4232, of the Act, additional members may be admitted as provided in the operating agreement, as amended from time to time.

#### ARTICLE VI PURPOSE

The Company is formed for the purposes of engaging in construction and development, and for any other lawful purposes.

#### ARTICLE VII CONTINUATION OF BUSINESS

Pursuant to Section 608.441(1)(d), Florida Statutes, this Company shall have the right to continue the Company's business upon the occurrence of any event that terminates this Company because there are no members.

## ARTICLE VIII MANAGEMENT OF THE COMPANY

This Company will be managed by one or more manager(s) appointed by the members in accordance with the terms of the operating agreement. As such, the Company will be manager-managed. Such managers will be responsible for the management of the day-to-day operations of the Company. In that regard, they shall have all the powers and authority permitted under the Act, except as may be expressly provided for in the operating agreement.
