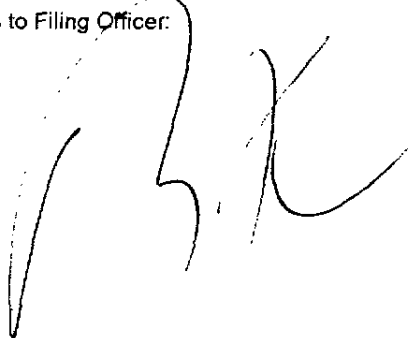

The name of the Limited Liability Company is EWE-KEYS, LLC (the "Company").

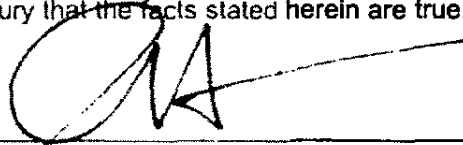
ARTICLE II - Address
