ARTICLES OF ORGANIZATION OF FURNITURE ENTERPRISES, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, <u>F.S. Chapter 608</u>, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be FURNITURE ENTERPRISES, L.L.C. ("Company").
