ARTICLES OF ORGANIZATION

OF

DESIGNED REMODELING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statues Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 – NAME

The name of the limited liability company shall be DESIGNED REMODELING, LLC

("Company")

ARTICLE 2 – ADDRESS

The principal place of business of the Company in Florida shall be 20051 NW 43 PLACE, MIAMI GARDENS, FL 33055

and the mailing address shall be the same.

ARTICLE 3 – EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4- DURATION

Subject to the provision of Article 9, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlied dissolved as provided in these articles of Organization.

ARTICLES 5 – PURPOSES AND POWERS

ARTICLE 10 – INDEMNIFICATION

The Company shall indemnify managers and officers of the Company who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the manager or officer was a party because the manager or officer is or was a manager or officer of the Company against reasonable attorney fees and expenses incurred by the manager or officer in connection with the proceeding. If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions. remaining shall not be otherwise affected. All references in these Articles of Organization to "manager," "officer," "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
