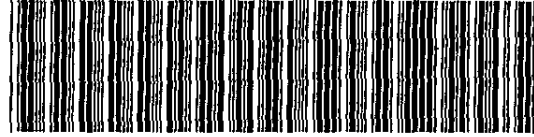

The name and the Florida street address of the initial registered agent is: Paul Belvitch, 5010 Administration Street, Port Charlotte, Florida 33948.

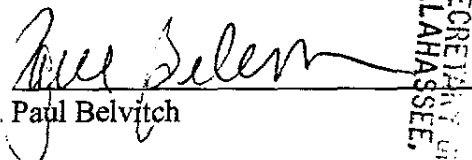
**ARTICLE IV — Management:**
