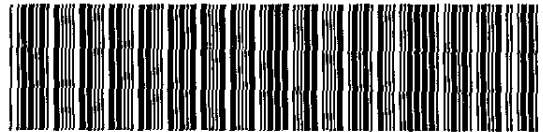

The principal place of business and mailing address of the Company is 4501 Beverly Avenue, Jacksonville, Florida 32210.



**ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS**

The Company shall be a manager-managed company as provided in the Operating Agreement.


