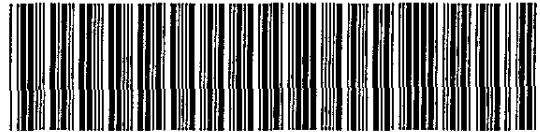

SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:

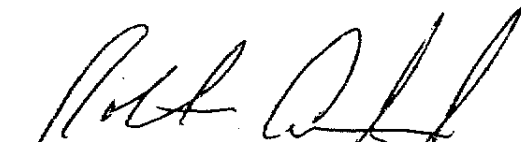
1. Article II of the Articles of Organization is amended as follows:
