FIRST: The name of the Limited Liability Company is:


Barrineau Park 20, LLC




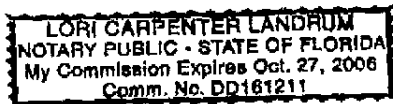
