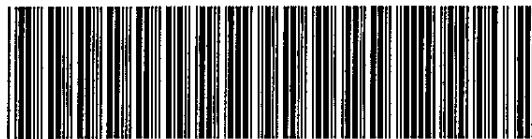

**ARTICLES OF ORGANIZATION  
OF  
FZD ENTERPRISES, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I**

The name of this limited liability company is FZD ENTERPRISES, LLC ("Company").

**ARTICLE II**

The mailing address and street address of the principal place of business of the Company is 631 U.S. Highway One, Ste. 402, North Palm Beach, FL 33408. The Company may at its discretion, at any time, change the address of its principal place of business.

**ARTICLE III**

**ARTICLE VI**


The power to adapt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the vote of a majority of its members.


