ARTICLES OF ORGANIZATION

OF

SDI MAIN STREET, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be SDI Main Street, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 2727 Bayshore Drive, Englewood, Florida 34223.

ARTICLE III - DURATION

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
