ARTICLES OF ORGANIZATION FOR

C & J HOLDINGS OF POLK COUNTY, LLC

The undersigned member hereby certifies to the following in order to form a Limited Liability Company under Chapter 608, Florida Statutes.

ARTICLE 1 - NAME

The name of the Limited Liability Company is C & J HOLDINGS OF POLK COUNTY, LLC.
