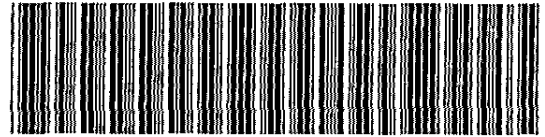

## ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is Leevest, LLC, a Florida limited liability company (the "Company").

4. Place of Business. The mailing and street address of the Company's principal office is 9220 Bonita Beach Road, Suite 215, Bonita Springs, Florida 34135.

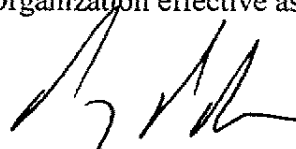

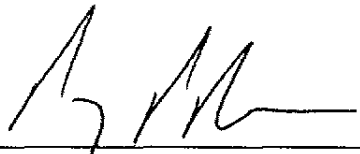
