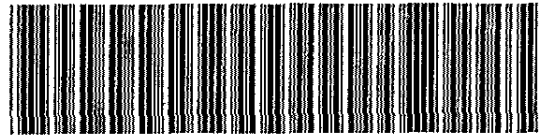

Principal Office

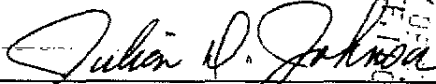

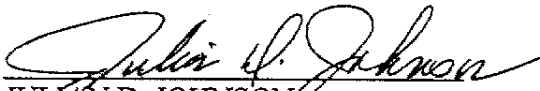
