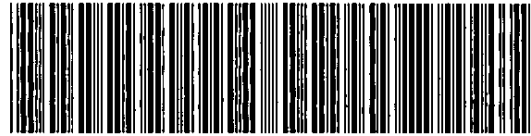



**Article I. Name.**


