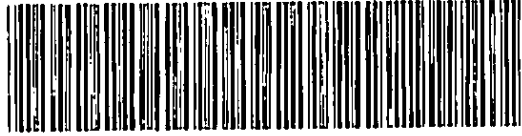

Article I. Name


