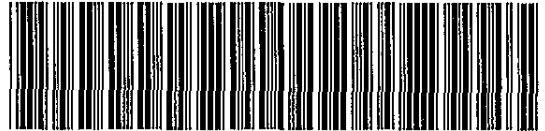

ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is John Foye, LLC, a Florida limited liability company (the "Company").

4. Place of Business. The mailing and street address of the Company's principal office is 11497 Osprey Landing Way, Fort Myers, Florida 33908.


