

# ARTICLES OF ORGANIZATION OF DEL-BRO PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Flor Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE I -- NAME

The name of the limited liability company shall be DEL-BRO PROPERTIES, LLC (hereinafter referred to as "Company").
