1. Name. The name of the Corporation is DORSEY ROAD, LLC (the "Corporation").

2. Articles of Incorporation. The date of filing of the Articles of Organization of the Corporation was March 11, 2005 (Document Number L05000024785).

3. Amendment. The Articles of Organization of the Corporation are hereby amended as follows:


Article 1 is deleted and a new Article 1 is inserted in lieu thereof, to read as follows:

ARTICLE 1 - NAME

The Name of the Corporation is CB RECEIVABLES, LLC. (hereinafter, the "Corporation").

4. Adoption of Amendment. Pursuant to Section 608.411 of the Florida Limited Liability Company Act, DORSEY ROAD, LLC adopts these Articles of Amendment. The foregoing amendment to Paragraph 1 was adopted and approved by the Members of the Company by written consent without a meeting, effective on December 5th, 2006.
