## **ARTICLES OF ORGANIZATION**

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby certify and adopt these Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability company shall be "EBC HOLDINGS, L.L.C." ("Company").

#### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company shall be 24 West Chase Street, Pensacola, Florida 32502.

#### **ARTICLE III - DURATION**

The Company shall commence on the date of filing these Articles of Organization with the Florida Department of State and the Company's existence shall be perpetual.

#### **ARTICLE IV - REGISTERED OFFICE AND AGENT**

#### **ARTICLE V - CAPITAL CONTRIBUTIONS**

The cash and/or property contributed to the Company by its members and the members' obligations to make additional contributions to the Company shall be as prescribed in the Regulations and Operating Agreement of the Company as adopted and agreed upon by the members.

#### **ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS**

The Company shall be manager-managed by a Board of Managers in accordance with the Regulations and Operating Agreement of the Company as adopted and agreed upon by the members.

**ARTICLE IX - AMENDMENT**

These Articles of Organization and the Regulations and Operating Agreement of the Company may be amended from time to time as prescribed in the Regulations and Operating Agreement of the company as adopted and agreed upon by the members.
