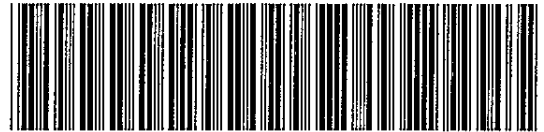

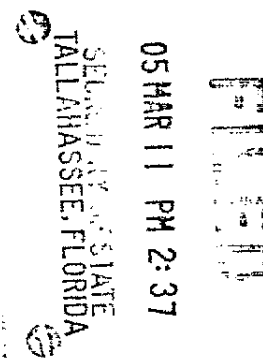

ARTICLE VI — Members' Rights to Continue Business



The Limited Liability Company shall not be dissolved by the death, retirement, resignation, expulsion, withdrawal, bankruptcy or dissolution of a member.


ARTICLE VII - Regulations.


