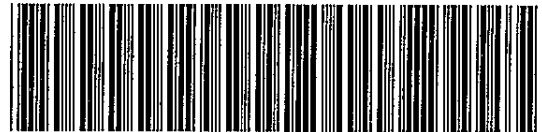

ARTICLES OF ORGANIZATION OF
DUNEDIN JAVA HOUSE, LLC

ARTICLE I
NAME

The name of the Florida limited liability company is **DUNEDIN JAVA HOUSE, LLC** (the "Company").

ARTICLE II
DURATION

The Company shall have perpetual duration.

ARTICLE III
PURPOSE

The Company is organized for the following purposes: to engage in any activity or business permitted under the laws of the United States, the State of Florida, and any other state or foreign country.

ARTICLE VI **NEW MEMBERS**

New Members may be allowed into the Company upon a majority vote of the Members then allowed to vote, with the initial contribution of such new Member to be determined by Majority vote of the Members at that time. Such voting shall be done on an ownership-share basis, rather than on a per-Member basis.

The remaining Members of the Company shall have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any Member of the Company, or in the occurrence of any other event which terminates the continued Membership of a Member in the Company.

ARTICLE VIII **MANAGEMENT**

The Company is to be managed by one or more members and is, therefore, a member - managed company.

ARTICLE IX **REGULATIONS**

The power to adopt, alter, amend, or repeal Regulations shall be vested in the Members of the Company, by voting conducted on an ownership-share basis.

ARTICLE X **INDEMNIFICATION**


The Company shall indemnify any Member, or any former Member, to the fullest extent permitted by law for all actions taken on behalf of the Company.
