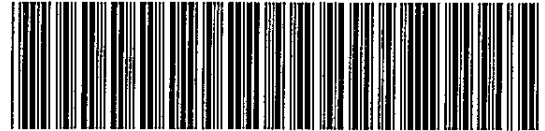


1. **Name.** The name of this company shall be Miami Gardens Park L.L.C..




