

#### ARTICLES OF ORGANIZATION OF MERCANTILE 4, LLC.

STATE OF THE PARTY THE UNDERSIGNED certifies he intends to form a limited liability company under th of the State of Florida and hereby declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

#### ARTICLE I NAME

The name of the limited liability company (the "Company") shall be MERCANTILE 4, LLC.
