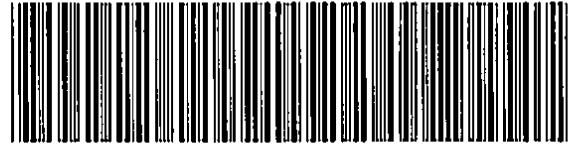



Pursuant to the provisions of section 605.0202, Florida Statutes, this Florida Limited Liability Company adopts the following amendment to its Articles of Organization:

**FIRST:** The Articles of Organization for this Limited Liability Company were filed on MARCH 14, 2005 with an effective date of MARCH 15, 2005 and assigned Florida document number L05000025690.

**SECOND:** Amendments adopted:

**ARTICLE X – Membership Units**


The total number of membership units authorized to be issued by the Company shall be Ten Thousand (10,000) authorized units, consisting of ten (10) voting units have a par value of Ten Cents (\$.10) per unit (the “Voting Membership Units”) and Nine Thousand Nine Hundred Ninety (9,990) nonvoting units having a par value of Ten Cents (\$.10) per unit (the “Nonvoting Membership Units”).


The voting and non-voting shares shall have identical rights and share equally in all distribution of profits, assets, dividends, earnings and such other distributions along with sharing equally as to any and all liquidation rights. Furthermore the voting and non-voting stock shall be deemed to be of the same class of stock.

**THIRD:** The date of the above amendments adoption is April 15, 2020.

**FOURTH:** Adoption of the above stated amendments was unanimously approved by the members and manager. The number of votes cast in favor of the amendment by both the members and managers was sufficient for approval of said amendment.
