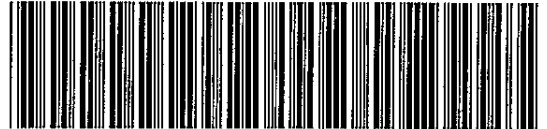

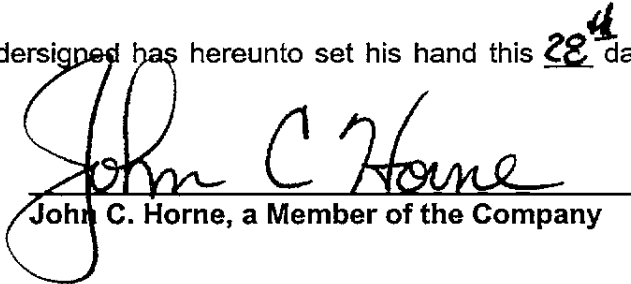
ARTICLE VII

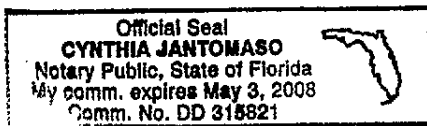
