

ARTICLES OF ORGANIZATION J.R. BUSINESS ENTERPRISES, L.L.C.

SARIS DE LO The undersigned, for the purpose of forming a limited liability company understage Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowled and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be J.R. BUSINESS ENTERPRISES, L.L.C., (Company").

ARTICLE II -- ADDRESS
