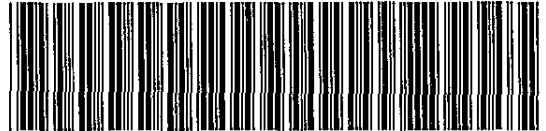


ARTICLE VIII. AMENDMENT
