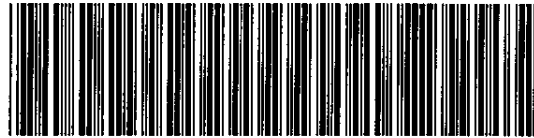



Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the undersigned, being the sole member of **CHRYSLIS CENTER FOR HEALTH TRANSFORMATION, SARAH T. LORD, M.D., PL**, amends the Articles of Organization of the Limited Liability Company originally filed with the Secretary of State of the State of Florida on March 15, 2005, as follows:

1. Amend and restate ARTICLE I - Name, to read as follows:
