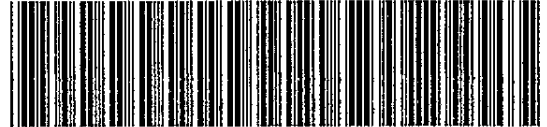

The name of the limited liability company shall be Kerrigan Enterprises, L.L.C., ("company").


ARTICLE II - ADDRESS


