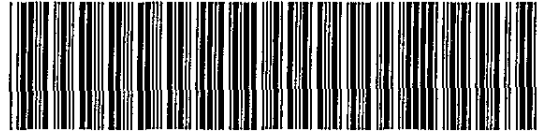

ARTICLES OF ORGANIZATION

OF

SECTION 1: NAME. The name of this Limited Liability Company shall be TACHYON COMPUTING SYSTEMS, LLC.
