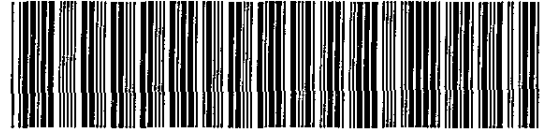

(Under Chapter 608 of the Florida Statutes)

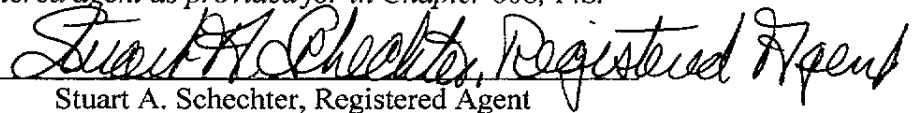
The undersigned person, acting as an organizer and member of the limited liability company hereinafter named, sets forth the following statements.
