ARTICLES OF ORGANIZATION OF

THE PRODUCE PEOPLE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **THE PRODUCE PEOPLE**, LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 5000 South Tamiami Trail, Venice, Florida 34293 and the mailing address shall be 754 Sugarwood Way, Venice, Florida 34292.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
