

#### ARTICLES OF ORGANIZATION

TO THE WAY OF THE PARTY OF THE

I, the undersigned subscriber to these Articles of Organization, being a natural person competent to contract, hereby execute this document for the purpose of becoming a limited liability company under the laws of the State of Florida.

#### **ARTICLE I: NAME**

#### ARTICLE II: BUSINESS AND MAILING ADDRESS
