ARTICLES OF AMENDMENT TO

JOVANOVIC & LYONS, LLC a Florida Limited Liability Company

UNANIMOUS CONSENT OF MEMBERS TO AMEND ARTICLES OF ORGANIZATION

The undersigned, being all of the members of JOVANOVIC & LYONS, Limited Earlity Company, a Florida limited liability company (the "Company"), hereby consent to the following amendment to the Articles of Organization of the Company:

ARTICLE III of the Articles of Organization of the Company is deleted in its entirety, and the following provision is inserted in lieu thereof:

"ARTICLE III: Purpose. The Company is organized solely to provide Architectural Services as defined by Chapter 481 of the Florida Statutes, and to engage in such other lawful activities as are reasonably necessary, convenient, or incidental to that purpose."

Additional Articles incorporated into the Articles of Organization of the Company are as follows:

ARTICLE VII — Management: The Company is to be managed by the members. However, Managing Member, Donald J. Lyons, has sole authority to supervise and control the rendering of architectural services as defined by Chapter 481 of the Florida Statutes and Chapter 61G1-23, Florida Administrative Code.

ARTICLE VIII — Limitation on Agency Authority of Members: Pursuant to section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.

ARTICLE IX —Membership Unit Restrictions: The Member Unit Certificates of the Company are subject to and may be transferred only in compliance with the provisions of applicable law and the Operating Agreement, a copy of which is on file at the Company's principal office. Further, if member units are increased the members shall be entitled to a pro-rata share of such increase upon payment for the units at the price at which the units are offered to others.
