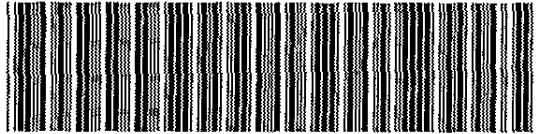

- FIRST:** The name and address of this corporation is **KEN CRANMER, LLC**, 4520 Skyline Blvd., Apt. 103, Cape Coral, Florida 33914.
- SECOND:** The date of the adoption of these Articles of Dissolution is 5 July 2006.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. 
