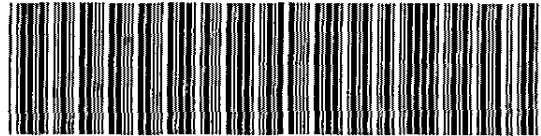



ARTICLES OF ORGANIZATION

OF

BULLSEYE LUMINOUS SPIRIT INVESTMENTS, L.L.C.

1. Name. The name of this limited liability company is Bullseye Luminous Spirit Investments, L.L.C., a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
