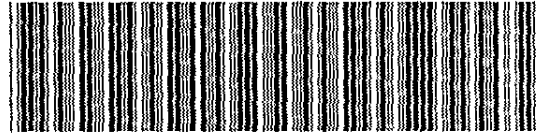

ARTICLE IV – MANAGEMENT

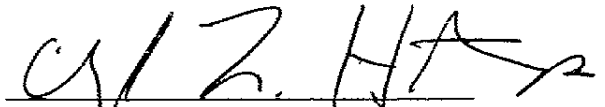
