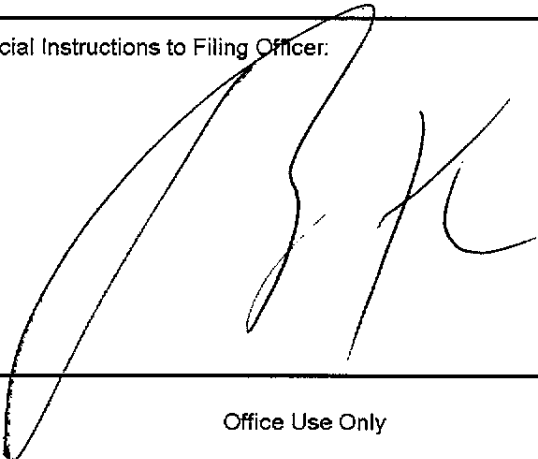

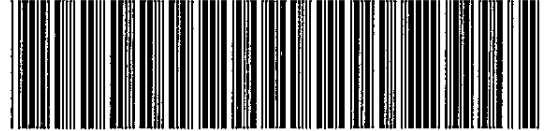

ARTICLES OF ORGANIZATION
OF
SEAFOOD DYNAMICS, LLC

THE UNDERSIGNED hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I
NAME

The name of the limited liability company (the "Company") shall be **SEAFOOD DYNAMICS LLC.**

ARTICLE II
ADDRESS

ARTICLE III
PURPOSES

The general nature of the business or businesses to be transacted and which the company is authorized to transact shall be as follows:

- A. To own, manage, operate and invest in businesses or entities engaged in the processing, distribution and sale of seafood, fish, seafood and fish products at wholesale and retail.
- B. To engage in any activity or business authorized under the Florida Statutes.

- C. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the state of Florida, and to do any and all things herein set forth to the same extend as a natural person might or could do.

ARTICLE IV DURATION

The duration for the Company is perpetual

ARTICLE V REGISTERED AGENT AND OFFICE

The name of the Company's initial registered agent in Florida is MICHAEL J. VOLPE and the address of the Company's registered agent in Florida is c/o Robins, Kaplan, Miller & Ciresi LLP, 711 Fifth Avenue South, Suite 201, Naples, Florida 34102.

ARTICLE VI MANAGEMENT

The Company is to be managed by the members. The initial managing members are identified as follows: **CHARLES MUNDT, III**, 10158 Boca Circle, Naples, Florida 34109 and **RICHARD CAHOON, JR.**, 15034 Spinnaker Court, Naples, Florida 34119.

ARTICLE VII ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.


ARTICLE VIII CONTINUATION OF BUSINESS OPERATIONS

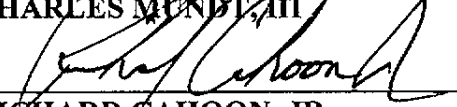

**ARTICLE IX

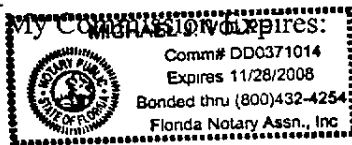

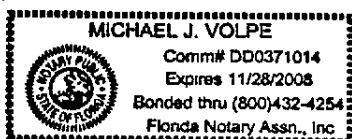
