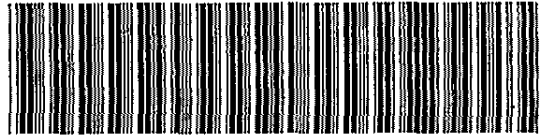





## ARTICLES OF DISSOLUTION


- TO: Department of State. — The undersigned Member-Manager presents these Articles of Dissolution for filing in accord with S.608.446:
