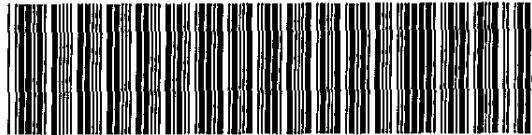

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is REYNOLDS & REYNOLDS PRIVATE ASSET MANAGEMENT, LLC

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 601 Cleveland Street, Suite 412, Clearwater, Florida 33755.






