ARTICLES OF ORGANIZATION OF INSTITUTE OF NUTRITIONAL MEDICINE AND CARDIOVASCULAR RESEARCH, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I --- NAME

The name of the Limited Liability Company shall be INSTITUTE OF NUTRITIONAL MEDICINE AND CARDIOVASCULAR RESEARCH, LLC (hereinafter "Company").

ARTICLE II --- ADDRESS

The mailing address and street address of the principal office of the Company shall be 1333 Golfside Drive, Winter Park, Florida 32792.

ARTICLE III --- DURATION

The Company commenced its existence on the $1/\pi t$ day of M2ct 2005 by electronically filing and subsequently filing the original Articles of Organization with the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV --- REGISTERED OFFICE AND AGENT

ARTICLE V --- CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the company the cash or property as mutually agreed between them.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTONS

Each member shall make additional capital contributions to the Company only on the unanimous consent of all the members.

ARTICLE VII - ADMISSION OF NEW MEMBERS

ARTICLE VIII -- TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE IX --- MANAGEMENT

The Company shall be managed by the managing member, William Scala in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
