ARTICLES OF ORGANIZATION

FOR

A Florida Limited Liability Company (FS Section 608,401)

The undersigned, hereby certify that we have associated ourselves together for the purpose of forming a limited liability Company under the laws of the State of Florida pursuant to Fla. 
