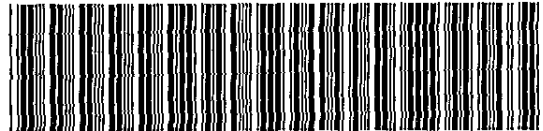

**ARTICLE IV**




