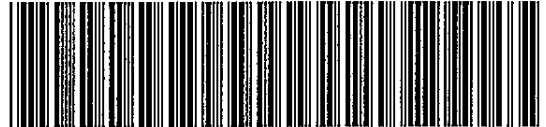



The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that: TALLAHASSEE, FLORIDA

**ARTICLE I - Name**

The name of the limited liability company (hereinafter referred to as the "Company") is "SOUTHERN REALTY OF MARION COUNTY, LLC."

**ARTICLE II - Address**
