ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED, acting as a member of a limited liability company organized under the Florida Limited Liability Company Act, adopt the following Articles of Organization for each limited liability company:

1. The name of the limited liability company is **LONMILLS, L.L.C.**
2. The period of its duration is perpetual.

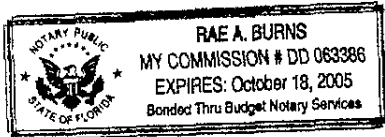
