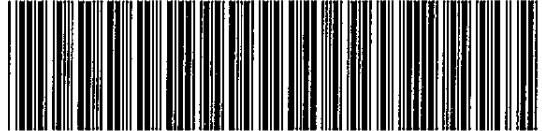

NAME**

The name of this limited liability company is FRANCIS ROAD, LLC

**ARTICLE II  
DURATION**

**IN WITNESS WHEREOF**, the undersigned has duly executed these Articles of Organization as of this 24<sup>th</sup> day of March, 2005.


