By these Amended and Restated Articles of Incorporation duly executed and filed pursuant to and in compliance with Section 608.411, the undersigned member, a natural person competent to contract, and who is licensed or otherwise legally authorized to render the professional services of a licensed real estate sales agent in the State of Florida, associates himself to form a Professional Services Limited Liability Company (the "Company") under Chapters 621 and 608 of the laws of the State of Florida, hereby certifies that:
