The existence of the Company shall begin on March 24, 2005.

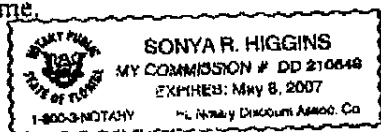



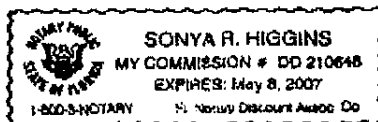
